## Who does the Kentucky Bar Foundation help?

As part of serving its mission, the KBF awards annual grants to law-related organizations and projects throughout the Commonwealth. It also supports statewide educational programs for high school and college students that are presented by Kentucky attorneys.

## How can you help by becoming a KBF Fellow?

The KBF Fellows Program recognizes members of the Kentucky Bar who have supported the KBF's mission through their success in the practice of law and generosity in contributing to the KBF. The program is designed to increase funds for the KBF's annual grants and to help grow the KBF's endowment fund.

As a Kentucky Bar Association member in good standing, you may become a **Life Fellow** through a one-time contribution of \$1,250. Alternatively, you may become a **Fellow** through an initial contribution of \$300 and a pledge to contribute an additional \$300 per year for the subsequent four years, at the end of which you will attain the status of Life Fellow.

A special option to become a **Fellow** is available for **young attorneys age 40 and under** and **attorneys employed by a governmental or nonprofit agency**. These attorneys may become Fellows by pledging to contribute \$1,500 over five years by authorizing the KBF to charge \$25 per month to their credit card or bank account until the pledge is completed. Those making this pledge will become Fellows after their monthly contributions total \$300 and will become Life Fellows after their contributions total \$1,500.

Fellows and Life Fellows are recognized by receiving a lapel pin and a certificate (Fellow) or plaque (Life Fellow) at the annual KBF luncheon held each year during the KBA convention. They also periodically receive invitations to activities hosted on their behalf and recognition in the *Bench & Bar*.
